In fact, the point that Mr. Parker raises in his motion is consistent with the plaintiff's position in this case. Should Mr. Parker want to individually sue (for money damages) in the future, he will likely be able to do so. See <i>Cole v. City of Memphis</i> , 839 F.3d 530, 541 (6th Cir. 2016), cert. denied sub nom. <i>City of Memphis, Tenn. v. Cole</i> , 137 S. Ct. 2220 (2017); <i>Berry v. Schulman</i> , 807 F.3d 600, 611-12 (4th Cir. 2015). But for now, the operating assumption is that "because the relief sought is uniform, so are the interests of the class members..." <i>Berry</i> , 807 F.3d at 612.
