
Upon consideration of the Motion for Second Amended Order of Dismissal and Enforcement of Amended Settlement Agreement, Supporting Declaration and Exhibits,

IT IS HEREBY ORDERED that the Amended Order of Dismissal entered in this case on August 31, 1999, is revised to allow sufficient time for the Center for the Study of Social Policy to complete its final audit report and for the Standards Committee to review such report and to

determine whether or not compliance with the terms of the Settlement Agreement has been achieved.

This Court now orders that it shall retain jurisdiction of this matter solely for the purposes of enforcing the terms of the Amended Settlement Agreement until December 31, 2001, unless further enforcement proceedings are pending in this Court on or before that date.
