AMENDMENT NO. 1 TO STIPULATION AND ORDER OF SETTLEMENT

WHEREAS the Stipulation and Order of Settlement (the "Stipulation") in this action was entered as an order of the Court on March 14, 2011;

WHEREAS, prior to this Amendment No. 1 to the Stipulation (the "Amendment"), the Effective Period of the Stipulation and the jurisdiction of the Court over the Stipulation were to terminate after March 13, 2016;

WHEREAS the parties desire to extend the Effective Period of the Stipulation and the jurisdiction of the Court over the Stipulation through June 30, 2016;

WHEREAS the parties also desire to extend the date by which Plaintiffs may move the Court for an order extending the jurisdiction of the Court over the Stipulation to April 30, 2016;

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned parties, as follows:

1. Amendments to the Stipulation.

(a) Paragraph 18 of the Stipulation is hereby amended by removing the first sentence of Paragraph 18 in its entirety and replacing it with the following: "The jurisdiction of the Court shall end after June 30, 2016 unless Plaintiffs move for and are granted an extension pursuant to paragraphs 22 and 23 of this Stipulation."

(b) Paragraph 23 of the Stipulation is hereby amended by replacing the phrase "a period of not more than one (1) year at a time from the date the Court's jurisdiction was scheduled to terminate" appearing in the second sentence thereof with "a period of not more than six (6) months at a time from the date the Court's jurisdiction was scheduled to terminate."
