

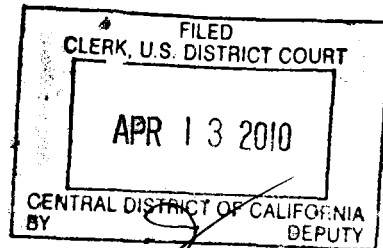



Based upon the stipulation of the parties and for good cause shown, IT IS HEREBY ORDERED that this action is certified as a class action under Rule 23(b)(2) of the Federal Rules of Civil Procedure. The class shall be defined as: All people with disabilities, as defined by the Americans With Disabilities Act, who are within the City of Los Angeles and the jurisdiction served by the City of Los Angeles' and County of Los Angeles' emergency preparedness programs and services. It is further ordered that named Plaintiffs Communities Actively Living Independent and Free ("CALIF") and Audrey Harthorn be designated as class representatives and that Plaintiffs' counsel, Disability Rights Advocates and Disability Rights Legal Center, be designated as counsel for the class.
