33 and costs by defendants for the period of October 1, 2007 through December 31, 2008, in this

36 the amount of \$24,180.81 will be paid to the Disability Rights Education and Defense Fund, and
37 attorneys' fees in the amount of \$43,614.00 will be paid to the Youth and Education Law Project.

1 In accord with the previous agreements of defendants, the attorneys' fees and costs
2 awards will be shared equally by the California Department of Education and the Ravenswood
3 City School District.

4 Defendants will take all reasonable steps to ensure that these monies will be paid no later
5 than 30 days after the Court has executed and entered the proposed Stipulated Order.

3 In view of the parties' stipulation, and good cause appearing thereof, the California
4 Department of Education and the Ravenswood City School District shall pay for the period of
5 October 1, 2007 through December 31, 2008 attorneys' fees and costs in the amount of
6 \$26,867.57 to be paid to the Disability Rights Education and Defense Fund, and attorneys' fees
7 in the amount of \$48,460.00 to be paid to the Youth Education Law Project.

8 The payments shall be equally divided between the California State Department of
9 Education and the Ravenswood City School District.

10 The monies shall be paid no later than 30 days after the execution and entering of this
11 Stipulated Order.
