THIS CAUSE came before the Court upon Plaintiff's Prayer for Temporary Injunction and after receiving testimony adduced and exhibits offered by all parties, and having heard oral argument by counsel for the respective parties to this action, this Court announced into the record at the conclusion of the hearing reasons and grounds for its ruling, which included but was not limited to, findings and determinations that the Plaintiffs had not shown by sufficient credible evidence that they were more likely to prevail upon the merits than not, nor that irreparable harm and injury would be suffered by Plaintiffs if the relief were denied; and that the Plaintiffs failed to show or establish any clear abuse of authority by the Defendant, Department of Health, Education and Welfare, in the administration and interpretation of "significant assistance" within the scope of its regulation adopted under the applicable statute and applied by it to the circumstances herein, it is thereupon -

ORDERED AND ADJUDGED that Plaintiffs' Prayer for Preliminary Injunction be and the same is hereby GRANTED.
