ORDER

Pending is Plaintiff's Motion to Strike Defendant's Affirmative Defenses (Doc. No. 8) and Defendant's response (Doc. No. 10).

Defendant's Answer was due on December 11, 2000. Defendant filed its Answer nine days late. Plaintiff asks that Defendant's affirmative defenses be stricken. A district court has discretion to deny a party's attempt to assert an untimely defense. See Irons v. Burlington Northern Railroad Company, 1993 U.S. App. LEXIS 12859 (8th Cir. 1993) (unpublished opinion) (citing Radio Corp. v. Hazeltine Research, Inc., 401 U.S. 321, 330-33 (1971) and L & L Marine Service, Inc. v. Insurance Co. of North America, 796 F.2d 1032, 1038 (8th Cir. 1986)).

The delay in the instant case was only a few days late and I see no prejudice to Plaintiff in this short delay. Accordingly, Plaintiff's motion is DENIED.
