STIPULATED JUDGMENT

In the interests of resolving the remaining state law claims for this matter under the "Amended Complaint of Plaintiffs/Interveners Tubandt, Henry, Brazle and Grubbs" (Dkt. #58; Counts 6 and 8 regarding assault and battery) by Plaintiffs/Interveners JESSICA J. TUBANDT, AMANDA HENRY, TIARA M. BRAZLE

1 AND TAMARA A. GRUBBS (“Plaintiffs/Interveners”) against Defendants STEVEN
2 ALAN EHRESMAN and SHARI LOUISE EHRESMAN (“Defendants Ehresman”), and
3 with full disclosure to the Court of the attached “Agreement to Consent to Judgment
4 and Covenant Not to Execute Judgment” and “Assignment” resulting from said
5 Parties’ comprehensive settlement negotiations, Plaintiffs/Interveners and
6 Defendants Ehresman, by and through their respective counsel undersigned, hereby
7 stipulate and agree to the Court’s entry of this Stipulated Judgment:

8 IT IS ORDERED, ADJUDGED AND DECREED:

9 1. Jessica J. Tubandt is awarded as against Defendants Steven Alan
10 Ehresman and Shari Louise Ehresman, husband and wife, and each of them, the
11 principal sum of Two Hundred Fifty Thousand Dollars (\$250,000), which sum shall
12 bear interest at the rate of 4.93% (as authorized pursuant to 28 U.S.C. § 1961(a))
13 from the date of this Judgment’s entry until paid in full.

14 2. Amanda Henry is awarded as against Defendants Steven Alan
15 Ehresman and Shari Louise Ehresman, husband and wife, and each of them, the
16 principal sum of Two Hundred Fifty Thousand Dollars (\$250,000), which sum shall
17 bear interest at the rate of 4.93% (as authorized pursuant to 28 U.S.C. § 1961(a))
18 from the date of this Judgment’s entry until paid in full.

19 3. Tiara M. Brazle is awarded as against Defendants Steven Alan
20 Ehresman and Shari Louise Ehresman, husband and wife, and each of them, the
21 principal sum of Two Hundred Fifty Thousand Dollars (\$250,000), which sum shall
22 bear interest at the rate of 4.93% (as authorized pursuant to 28 U.S.C. § 1961(a))
23 from the date of this Judgment’s entry until paid in full.

24 4. Tamara A. Grubbs is awarded as against Defendants Steven Alan
25 Ehresman and Shari Louise Ehresman, husband and wife, and each of them, the
26 principal sum of Two Hundred Fifty Thousand Dollars (\$250,000), which sum shall

1 bear interest at the rate of 4.93% (as authorized pursuant to 28 U.S.C. § 1961(a))
2 from the date of this Judgment's entry until paid in full.


3 5. Pursuant to rulings made under this Court's October 26, 2006 "Order"
