This decree represents the compromise of disputed claims which the parties recognize would require protracted and costly litigation. The sum of \$220,000 which is to be paid by defendant in accordance with the terms hereof in full settlement of all claims for monetary relief to eligible class members. The effective date of this decree is the date upon which the court gives final approval to the decree. This decree fully and completely resolves and releases defendant from any and all class issues, claims and allegations concerning defendant's alleged discriminatory hiring practices at the Coconut Club based upon age or any other protected category. In settlement of all monetary claims of the charging party and the eligible class members, defendant shall pay the following: In full settlement of all claims for monetary relief, defendant shall pay the sum of \$220,000 within a period of three years following the effective

date of decree. Each party shall bear its own attorneys' fees and costs, except that defendant shall bear the costs for the hiring of the EEO consultant and the administration and payment of claims to all eligible and subsequent eligible class members terminating case (MD JS-6) (bg) (Entered: 02/27/2003)
