ORDER

Before the court is **Defendant's Motion To Compel Compliance With Rule 26** (Dkt.122), which was filed on March 20, 2002.

Defendant seeks an order compelling Intervenor, Antonio Anglin, to provide Defendant with specific figures for the amount of compensatory and punitive damages Anglin seek from Defendant. Defendant also seeks an order compelling Anglin to provide specific information supporting and explaining Anglin's back pay calculations in his Rule 26(a)(1) initial disclosures and documentation supporting such calculations. To date, Intervenor has not responded to this motion.

The Local Rules of this district provide that a party shall respond within ten (10) days to any motion to which it is opposed.

Accordingly, it is **ORDERED and ADJUDGED**:

(1) Defendant's motion to compel compliance with Rule 26 (Dkt.122) is **GRANTED**. Intervenor, Antonio Anglin shall serve Defendant with specific figures for the amount of compensatory and punitive damages he seeks, specific information supporting and explaining Anglin's back pay calculations and documentation supporting Anglin's back pay calculations within ten days from the date of this order.
