Plaintiff, PHYLLIS LOPEZ, states as follows:

**Jurisdiction and Venue**

1. This is an action for relief to redress the deprivation of Plaintiff's rights secured by Title VII of the Civil Rights Act of 1964, as amended, 42 U.S.C. § 2000e *et seq.*
2. This Court has jurisdiction of this action under 28 U.S.C. § 2000e-5(f)(3).
3. Venue is proper pursuant to 28 U.S.C. § 1391(a).

**Parties**

4. Plaintiff, PHYLLIS LOPEZ is a female citizen of the United States and Illinois. At all times relevant herein, Plaintiff has resided in the district of this Court. Plaintiff was an employee of the Defendant INTERNATIONAL PROFIT ASSOCIATES, INC. ("IPA") from on or about August 16, 2001 until on or about September 25, 2001, when she was constructively discharged.
5. Defendant IPA is an Illinois business entity. Defendant is and was at all relevant times herein, an "employer" within the meaning of Title VII, 42 U.S.C. § 2000e(b).

### **Administrative Procedure**

6. On or about March 11, 2002, and within 300 days of the last act of discrimination, Plaintiff filed a charge of discrimination with the United States Equal Employment Opportunity Commission ("EEOC"), a copy of which is attached as Exhibit "A" to this Complaint.

7. On or about March 28, 2002, a "Notice of Right to Sue" was issued from the District Office of the EEOC for the charge of discrimination (a copy of which is attached to this Complaint as Exhibit "B"), entitling Plaintiff to institute a civil action in the appropriate Federal District Court within 90 days of the date of receipt of the notice. The notice was received by Plaintiff on April 1, 2002.

8. Plaintiff's last position with IPA was as a file clerk/secretary.

9. At all relevant times, plaintiff performed her employment duties in a satisfactory manner.

10. Shortly after she began working at IPA, and continuing throughout her employment with IPA, plaintiff was sexually harassed and sexually discriminated against by management, supervisors and employees of IPA. This unlawful discrimination and harassment included, but was not limited to the following:

- a. Being approached by John Greco, Gordon Gurney and Joe Woods, supervisors at IPA, and being told by them that she must have sex with Dan Druggan, the Director of Sales for IPA. She was told that she was doing well at IPA, and that if she wanted to continue to do well, she would do what she was told. Further, money was offered to her if she had sex with Dan Druggan, and a job promotion was promised. Plaintiff was also told that if she did not "give in" her job would be on the line. Also, when the men approached her, they would say disgusting things of a sexual nature, such as "go suck Druggan's dick.";
- b. After the men listed above approached plaintiff and made their demands, and the demands were refused as they always were, they would then yell at plaintiff and swear at her for not giving in to the demands by saying such

things as “what the fuck is wrong with you...?;

- c. Mr. Woods grabbing plaintiff after making the demands listed in sub-section a;
- d. Dan Druggan, Director of Sales for IPA, directly approaching her and demanding sex; and
- e. Being approached by a co-worker at the request of management and/or supervisors of IPA, and being asked if she would take money in exchange for not telling anyone about the events listed in sub-sections a-d.

11. The acts alleged above were directed to plaintiff because she is female, and the acts created a hostile work environment.

12. As a result of the hostile work environment, it was impossible for plaintiff to continue to work at IPA, and she left IPA, being constructively discharged on or about September 25, 2001.

13. IPA supervisory and management level personnel had knowledge of each and every act alleged above, and did nothing to remedy the situation and as a result, the acts of sexual harassment and sexual discrimination continued throughout plaintiffs employment with IPA. Due to defendant’s discriminatory behavior, plaintiff has suffered monetary damage and emotional pain and suffering.

WHEREFORE, Plaintiff, PHYLLIS LOPEZ, prays that this court enter judgement in her favor and against Defendant, INTERNATIONAL PROFIT ASSOCIATES, INC. as follows:


- a. That a finding be entered that Defendant violated Title VII by sexually discriminating against Plaintiff;
- b. That Plaintiff be awarded the maximum monetary damages available;
- c. That Plaintiff be awarded all wages, benefits and other compensation due to her being constructively discharged by IPA;
- d. That Plaintiff be awarded punitive damages;
- e. That Plaintiff be awarded reasonable attorney’s fees and costs; and
- f. That Plaintiff be awarded such other relief as this court deems proper.

CONTINUING ACTION

THE PARTICULARS ARE (If additional space is needed, attach extra sheet(s)):

- I. I started working at IPA on August 16, 2001.
- II. Almost immediately after I started working, supervisors, Joe Wood, John Greco and Gordon Gurnee approached me on behalf of President Dan Druggan and told me to have sex with him. This happened to me constantly while I worked at IPA. Money was offered to me if I had sex with Mr. Druggan, and a job promotion was promised.
- III. Each time I was approached, I told the three (3) individuals that their approaches were unwelcome. On one occasion, Mr. Wood actually grabbed my right arm. All of the men would yell at me and swear at me for not giving in.
- IV. When the men approached me they said disgusting things of a sexual nature.
- V. I was told that if I did not "give in" my job would be on the line.
- VI. Although I complained to the appropriate supervisory and management personnel, nothing was done. In fact, the Human Relations Department tried to cover up what was going on. I was even offered money by the Human Relations Department. The owner of the company, a Mr. Burgess wouldn't even see me.
- VII. It should be noted that Dan Druggan himself also directly approached me for sex.
- VIII. I was also approached by a co-worker and asked if I would take money in exchange for not telling anyone about what had transpired.
- IX. I wish to note that what happened at IPA has had a terrible effect on my life.
- X. I believe that I have been discriminated against because of my sex and that this discrimination is in violation of Title VII of the 1964 Civil Rights Act as Amended.


