

In Damien Duplesis, et al v. Lakeside Imports, Inc. et al, CA 99-3733 "S"(1) three motions are pending: (1) motion of defendant, Lakeside Imports, Inc. to dismiss plaintiffs' claims of discrimination under 42 U.S.C. § 1981 (Rec. doc. 4 in CA 99-3733), (2) motion of defendants, Anthony Gullo, Keith Hanks, John Prendel, to dismiss plaintiffs' complaint (Rec. doc. 5 in CA 99-3733), and (3) motion of defendant, Christopher Mohrman, for summary judgment and to dismiss plaintiffs' complaint pursuant to Rule 12(b)(6) (Rec. doc. 9 in CA 99-3733).

On June 2, 2000, the court entered a 60 day dismissal order in these consolidated actions, but specifying that the claims by the United States Equal Employment Opportunity Commission against Lakeside Imports, Inc. are unaffected by that order. Inasmuch the referenced motions were filed in CA 99-3733 and the claims asserted by the plaintiffs in that action are subject to the 60 day dismissal order, it is ORDERED that the motions are DENIED as MOOT.
