Of the various individuals identified in LSN's preliminary witness list, it has indicated that it will call Darrell Guillory, David Cleffinger, Steven Byrd, and Trish Adams' sister to testify at the trial of this matter. Due to the lateness of their identification, these witnesses are to be produced by defendant in Hammond on October 5, 2000 for deposition purposes, said depositions to be conducted at defendant's expense. At said depositions, defendant shall also produce the personnel files of the Charging Party, Trish Adams, Willie Pitre, and Beth Begnaud as well as the items identified on defendant's preliminary exhibit list with the exception of numbers 7, 9, 10, and 13. A brief narrative of the four deponents' expected trial testimony is to be furnished to plaintiff in advance of the October 5, 2000 depositions.

With respect to Interrogatory No. 11 and related Request for Production of Documents No. 7, plaintiff is to question Mr. Guillory on October 5, 2000 as to the type of financial records that are available. Once so identified, if the production of those record cannot be resolved by counsel, the Court is to be notified.

As for Interrogatory No. 15 and Request for Production of Documents Nos. 8 and 10, those answers and responses are to be supplemented on behalf of LSN.

Defendant's Answer to Interrogatory No. 17 is sufficient as written.

With respect to Request for Production of Documents No. 15, defendant is to supplement its response to answer for both entities.

Defendant is to also query Trish Adams as to who she remembers hiring in March of 1997 for purposes of Request for Production No. 16.

Unless a different time frame is noted, the supplementation ordered above is to be provided, if at all possible, by October 5, 2000 but in no event later than October 10, 2000.
