COMPLAINT AND JURY  
TRIAL DEMAND

MAGISTRATE JUDGE CAPEL

NATURE OF THE ACTION

This is an action under Title VII of the Civil Rights Act of 1964, and Title I of the Civil Rights Act of 1991, to correct unlawful employment practices on the basis of race, and to provide appropriate relief to Doraretha McKee, Aaron Laird, Robert Shaw, Roderic Boone, Anita Claxton, Johnny Farmer and Nicklas Maddox, and other similarly situated persons who were adversely affected by such practices. The EEOC alleges that Defendant, Michigan Seamless Tube, ("Defendant" or "Michigan Seamless") discriminated against these individuals and persons similarly situated by failing to hire them because of their race, African American.

JURISDICTION AND VENUE

1. Jurisdiction of this Court is invoked pursuant to 28 U.S.C. §§ 451, 1331, 1337, 1343, and 1345. This action is authorized and instituted pursuant to Sections 706(f)(1) and (3) of Title VII of the Civil Rights Act of 1964, as amended, 42 U.S.C. 2000e-5(f)(1) and (3) ("Title VII"), and

Section 102 of the Civil Rights Act of 1991, 42 U.S.C. § 1981a, 28 U.S.C. §§ 451, 1331, 1337, 1343 and 1345.

2. The employment practices alleged to be unlawful were and are now being committed within the jurisdiction of the United States District Court for the Eastern District of Michigan, Southern Division.

3. Plaintiff, the Equal Employment Opportunity Commission, ("EEOC" or the "Commission") is the agency of the United States of America charged with the administration, interpretation and enforcement of Title VII, and is expressly authorized to bring this action by Section 706(f)(1) and (3) of Title VII, 42 U.S.C. §§ 2000e-5(f)(1) and (3).

4. At all relevant times, Defendant, Michigan Seamless, has continuously been a corporation doing business in South Lyon, Michigan, and has continuously had over 15 employees.

5. At all relevant times, Defendant Employer has continuously been an employer engaged in an industry affecting commerce within the meaning of Sections 701(b), (g), and (h) of Title VII, 42 U.S.C. §§ 2000e(b), (g), and (h).

#### **STATEMENT OF CLAIMS**

6. More than thirty (30) days prior to the institution of this lawsuit, Doraretha McKee, Aaron Laird, Robert Shaw, Roderic Boone, Anita Claxton, Johnny Farmer and Nicklas Maddox, filed charges with the Commission alleging violations of Title VII by Defendant Employer. All conditions precedent to the institution of this lawsuit have been fulfilled.

7. Since at least October 2002, Defendant Employer has engaged in unlawful employment practices at its South Lyon, Michigan facility, in violation of Section 703(a), 42 U.S.C. § 2000e-2(a). The unlawful employment practices include failing to hire Doraretha McKee, Aaron

Laird, Robert Shaw, Roderic Boone, Anita Claxton, Johnny Farmer and Nicklas Maddox, and persons similarly situated, because of their race, African American.

8. The effect of the unlawful conduct complained of in paragraph 7, above, has been to deprive Doraretha McKee, Aaron Laird, Robert Shaw, Roderic Boone, Anita Claxton, Johnny Farmer, Nicklas Maddox and others similarly situated of equal employment opportunities and otherwise adversely affect their status as employees because of their race, African American.

9. The unlawful employment practices complained of in paragraph 7, above, were and are intentional.

10. The unlawful employment practices complained of in paragraph 7, above, were done with malice or with reckless indifference to the federally protected rights of Doraretha McKee, Aaron Laird, Robert Shaw, Roderic Boone, Anita Claxton, Johnny Farmer, Nicklas Maddox and others similarly situated.

**PRAYER FOR RELIEF**

Wherefore, the Commission respectfully requests that this Court:

A. GRANT a permanent injunction enjoining Defendant Employer, its officers, successors, assigns, and all persons in active concert or participation with it, from engaging in race discrimination in hiring, and any other employment practice which discriminates on the basis of race;

B. ORDER Defendant Employer to institute and carry out policies, practices, and programs which provide equal employment opportunities for African Americans, and which eradicate the effects of its past and present unlawful employment practices;

C. ORDER Defendant Employer to provide training on Title VII of the Civil Rights Act of 1964, as amended, and its prohibitions against race discrimination to all of its employees at its

South Lyon, Michigan facility and its human resources department;

D. ORDER Defendant Employer to make whole Doraretha McKee, Aaron Laird, Robert Shaw, Roderic Boone, Anita Claxton, Johnny Farmer, Nicklas Maddox and others similarly situated by providing appropriate monetary relief, in the form of back pay, pecuniary and compensatory damages in the amounts to be proven at trial;

E. ORDER Defendant Employer to pay Doraretha McKee, Aaron Laird, Robert Shaw, Roderic Boone, Anita Claxton, Johnny Farmer, Nicklas Maddox and others similarly situated punitive damages for its malicious or reckless conduct described in paragraph 7, above, in amounts to be proven at trial;

F. ORDER Defendant Employer to make whole Doraretha McKee, Aaron Laird, Robert Shaw, Roderic Boone, Anita Claxton, Johnny Farmer, Nicklas Maddox and others similarly situated by providing appropriate fringe benefits they would have been entitled to had they not been subjected to unlawful discrimination.

G. GRANT such further relief as the Court deems necessary and proper in the public interest; and

H. AWARD the Commission its costs for this action.

**JURY TRIAL DEMAND**

The Commission requests a jury trial on all questions of fact raised by its Complaint.
