26 Defendant, Sako Corporation, has defaulted in this action. Its entry of default was
27 entered on January 10, 2005. The issue of the amount of damages sustained by plaintiff was

plaintiff suffered damages in the amount of ONE MILLION EIGHTY SEVEN THOUSAND
