ORDER OF DISMISSAL WITH PREJUDICE

This cause is before the Court pursuant to a Stipulation of Dismissal filed by all parties requesting entry of an order of dismissal with prejudice of Latasha Jackson's claims against PIC in the above captioned lawsuit. The Court, having considered the stipulation, finds that Latasha Jackson and PIC have reached a compromise and settlement of this cause, so that there remain no issues to be tried or determined by this Court. The Court, being otherwise fully advised in the premises, is of the opinion, and so finds, that the stipulation should be received by the Court and that all of Latasha Jackson's claims against PIC the above-captioned action should be dismissed, with prejudice, and that each party shall bear its own costs of litigation and attorneys' fees.

IT IS, THEREFORE, ORDERED AND ADJUDGED that all claims asserted by Latasha Jackson against Productivity Improvement Center, Inc., in the above captioned lawsuit herein be, and the same are hereby, dismissed with prejudice, with each party to bear its own costs and attorneys' fees; provided, however, that the Court retains jurisdiction to enforce the "Settlement Agreement and Full and Final General Release" entered into by the Latasha Jackson

and Productivity Improvement Center, Inc.
