For instance, in plaintiffs' responsive memo to the motion <u>138</u> at p. 82–83, plaintiffs cite "Fitzgerald Dep. 6:9–7:15, 87:1–8, 307:11–14" without directing the court as to where to find this deposition document. The court eventually found the document attached to the First Declaration of Counsel in Support of Plaintiff and Plaintiff Intervenors' Response <u>96</u> as Exhibit 9 (which itself is actually document <u>98</u>). For another example, in Qwest Corporation's memo <u>81</u> , defendant, at p. 10, cites "Parra Ex. 11, at 9." The court searched the record and found that the declaration of David P.R.
