**ORDER GRANTING DEFENDANT'S MOTION TO COMPEL (ARMSTRONG)**

On November 26, 2001, defendant Northwest Airlines, Inc. ("Northwest") filed its motion seeking an order compelling intervening plaintiff Kevin Armstrong ("Armstrong") to produce his calculations of alleged damages resulting from the alleged wrong(s) committed by Northwest within the time(s) covered by this lawsuit. Armstrong responded by asserting that, until he is able to examine copies of personnel records of employees hired at or about the time he was refused employment (as requested from Northwest by the plaintiff Equal Employment Opportunity Commission ("EEOC")), he will not be able to make such calculations.

This court has now entered a Protective Order which will have the effect of requiring Northwest to produce these documents to the EEOC.

Plaintiff Armstrong is therefore ORDERED to provide the information requested by Northwest within FIFTEEN (15) DAYS of receipt of the above personnel information. This information may be shared by the EEOC, provided there is a clear understanding on the part of Armstrong and his counsel of the provisions of the Protective Order.

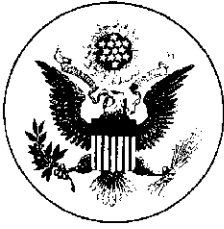
