ORDER

On March 15, 2002, Connie R. Hicks filed a Notice of Appeal of Decision of Settlement Fund Administrator, objecting to the decision of the Settlement Fund Administrator. In order to review this claim, the court hereby **ORDERS** as follows:

1. Not later than April 16, 2002, the Settlement Fund Administrator, Robert H. Peterson, is **ORDERED** to provide the court with written reasons or a written decision regarding the decision challenged by Ms. Hicks; and to forward to the court copies of any record that he deems appropriate or necessary for the court's review of this matter.
2. Not later than April 29, 2002, any party may file a response to the Notice of Appeal of


1 Decision of Settlement Fund Administrator.

2 3. Not later than May 2, 2002, any party may file a reply to any of the responses.

3 4. The Appeal of the Settlement Fund Administrator (Dkt. 65) is noted for consideration on
4 the court's May 3, 2002 calendar.

5 The Clerk is directed to send uncertified copies of this Order to all counsel of record, to any party
6 appearing *pro se* at said party's last known address, and to Robert J. Peterson. The Clerk is further
7 directed to include a copy of the Notice of Appeal of Decision of Settlement Fund Administrator (Dkt. 65)
8 with each copy of this order sent to the parties.
