PREJUDICE AND GRANTING IN PART
PETITIONERS' MOTION FOR INTERIM
AWARD OF ATTORNEY'S FEES AND
COSTS

Petitioners' Motion for Interim Award of Attorney's Fees and Costs Pursuant to Code of Civil Procedure section 1021.5 came on for hearing in the Law and Motion Department on June 17, 2014. Having considered the written submissions and the arguments of counsel, the motion is denied in part without prejudice and granted in part as follows:

1. Petitioners' motion for interim attorney's fees pursuant to Code of Civil Procedure section 1021.5 is denied without prejudice. An award of attorney's fees pursuant to section 1021.5 is premature at this stage of litigation, which has not concluded and has been remanded for further proceedings. (*Sander v. State Bar of Cal.* (2013) 58 Cal. 4th 300.)

1 2. Petitioners' claim for appellate costs in the amount of \$6,336.01 is granted.


