CONSENT JUDGMENT

This Court has been apprised that the parties have conferred regarding Plaintiffs' claims for reasonable attorneys' fees and costs for legal work performed during the period of April 2001 through September 30, 2001. Having reached an agreement regarding the amount to be paid by the Defendants for such fees, costs and expenses, the below-referenced counsel have jointly requested that the Court enter this Consent Judgment, which reflects the agreement. The parties agree that this settlement shall not be construed to apply to or affect in any way the treatment of future claims for attorneys' fees and costs.
