ORDER

For the reasons set forth in the accompanying Memorandum Opinion and in *Coreas v. Bounds*, No. TDC-20-0780, 2020 WL 1663133 (D. Md. Apr. 3, 2020), it is hereby ORDERED that:

1. The Renewed Motion for a Preliminary Injunction filed by Petitioners Angel Guzman Cedillo and William Kemcha (“Petitioners”), ECF No. 79, is GRANTED.

2. Guzman Cedillo and Kemcha shall be RELEASED from Worcester County Detention Center within 24 hours of this Order, on the following conditions:
 - a. Guzman Cedillo shall reside at 1032 University Boulevard, Apartment 102, Silver Spring, Maryland.
 - b. Kemcha shall reside at 13151 Larchdale Road, Apartment 10, Laurel, Maryland.
 - c. Petitioners shall self-quarantine at their respective addresses for the first 14 days following their release. Thereafter, they may not travel outside of Maryland, Virginia, or Washington, D.C. without the advanced permission of U.S. Immigration and Customs Enforcement (“ICE”).
 - d. Petitioners shall be subject to location monitoring, at the discretion of ICE.
 - e. Petitioners shall appear, either in person or telephonically, as required by ICE upon reasonable notice, including at any hearing in their immigration proceedings and for removal if ordered.
 - f. Petitioners shall assist ICE in obtaining necessary travel documents for them, including that Kemcha shall comply with the requirements relating to travel documents set forth in ECF No. 86-4.
 - g. Guzman Cedillo shall comply with the terms of supervised release set in *United States v. Guzman*, No. ELH-19-0139 (D. Md.), including reporting to his assigned United States Probation Officer, by telephone if necessary, within 72 hours of release from ICE custody. Guzman Cedillo shall provide ICE with the officer’s name, address, and telephone number, and the reporting requirements.

- h. To the extent that either Petitioner is subject to any other form of court supervision, such as probation or parole, he shall report to the assigned probation officer or parole officer within five business days of release, by telephone if necessary, and shall follow all reporting and supervision requirements mandated by that office, and provide ICE with the officer's name, address, and telephone number, and the reporting requirements.
 - i. Petitioners shall not commit any federal, state, or local crime and shall comply with all government orders relating to the COVID-19 pandemic.
 - j. Petitioners shall not associate with known gang members or individuals engaged in criminal activity and shall not be associated with gang or criminal activities.
 - k. Petitioners shall continue to follow any existing doctor's orders relating to physical or mental health, including taking prescribed medications.
3. No bond will be required of Guzman Cedillo or Kemcha.
