
ORDER

Plaintiffs have noticed a motion to reconsider, modify and augment the findings and recommendations issued in this case on August 1, 1991, for hearing on September 19, 1991 at 9 a.m. The Findings and Recommendations are presently before the district court, together with plaintiffs' objections which incorporate the noticed motion. Accordingly, plaintiffs' motion is inappropriately noticed for hearing before this court. Plaintiffs have also noticed a motion for the award of interim attorneys' fees for the same time and date. Because final judgment is imminent, after which plaintiffs may move for attorneys' fees for the entire
