On September 4, 1992, the magistrate judge filed findings and recommendations herein which were served on all parties and which contained notice to all parties that any objections to the findings and recommendations were to be filed within fifteen (15) days. On October 5, 1992, after an extension of time was granted, plaintiffs filed timely objections to the findings and recommendations.
