ORDER

29 Having been advised that a Federal criminal Grand Jury investigation out of
30 the Central District of California is pending against Defendants Deputy
31 Zunggeemoge, Deputy Ayala, Deputy Luviano, Deputy Womack and Sergeant
32 Gonzalez, and that these Defendants would invoke their Fifth Amendment Right
33 against self incrimination at a Deposition, and in their responses to Requests for
34 Admissions and / or Interrogatories, the Court hereby finds that GOOD CAUSE
35 HAS BEEN SHOWN and IT IS HEREBY ORDERED that the instant proceedings,

1 including all discovery matters, is stayed, and the trial and all related dates are
2 vacated.

3 IT IS FURTHER ORDERED that the parties are to file a joint report with the
4 Court by July 12, 2013, advising the Court of the status of the criminal Grand Jury
5 investigation and any settlement negotiations between the parties. If the criminal
6 Grand Jury investigation is no longer pending and there are no criminal charges
7 pending against any of the defendants, the parties are to file a revised proposed
8 Schedule of Trial and Pretrial Dates with the Court by July 12, 2013.
