Tech-Bilt did not hold that it is procedurally improper to have trial before evaluating whether a settlement agreement was reached in good faith. The court held that when a court determines whether parties made a good-faith settlement under California Code of Civil Procedure section 877.6, the court must apply a proportionate liability test (i.e., the settlement must be within the reasonable range of the settling tortfeasors share of liability for the plaintiffs injuries). Tech-Bilt, 38 Cal. 3d at 499. Equally important, all parties were aware of the settlement between Plaintiffs and Regents since at least March 31, 2017 (the pretrial conference hearing date). Yet no party said anything at the conference about the possibility of continuing this trial until the settlement was approved by this Court. To raise this issue on the eve of trial causes the Court significant concern that the motion is made as a tactical maneuver. Such maneuvers are not well received by this Court. As for Plaintiff Mayfields Application to Shorten Time on Determination of Good Faith Settlement, ECF No. 363, for the reasons stated above, the Court also denies his request.
