
NOTICE OF AMENDMENT TO  
STIPULATION AND AGREEMENT OF PARTIAL SETTLEMENT

As a member of the plaintiff class in Arias, et al. v. Wainwright, Case No. TCA 79-0792, you recently were provided Notice of the Proposed Conditions and Terms of Partial Settlement of this cause by Notice of Proposed Partial Settlement signed and dated by United States Magistrate Crongeyer on July 9, 1981. Page No. 3 of the Stipulation and Agreement of Partial Settlement states that the support of Florida Governor Bob Graham is indicated within that Stipulation document. The Stipulation distributed did not and will not contain that indication, however.

Governor Graham is not a defendant in this lawsuit. The absence of that indication of support from him does not and will in no way impede Defendant Secretary of the Florida Department of Corrections Wainwright's commitment to fully comply with and carryout all terms of this Settlement Agreement. In order to insure you a full opportunity to comment on the proposed settlement, you are herein advised of your right, per agreement between your legal counsel and legal counsel for Defendant Wainwright, to submit, within 20 days of receipt of this Notice, amended written comments or written objections to the Honorable Marvin S. Waits, Clerk, United States District Court for the

Northern District of Florida, Post Office Box 958, Tallahassee, Florida 32302. Please be certain that you include at the top of your comments or objections the caption of this case and the case number, just as it appears at the top of this Notice of Amendment.


