ORDER

This matter is before the Court by reason of the Amended Complaint of Plaintiffs, individually, and as representatives of a class with the Court having heretofore ruled that the action is properly maintainable by Plaintiffs as a class action with the class represented being all persons who are now confined or have been confined or will be confined in the City Jail of St. Louis. The Court after a full evidentiary trial finds the rights guaranteed to Plaintiffs and the class by the Constitution of the United States including the Eighth and Fourteenth Amendments thereto have been violated by the conditions of the detention at the City Jail of St. Louis, and the Court ORDERS that the City Jail of St. Louis be closed as a place of confinement for the Plaintiffs and the class and that the Derendants be enformed from incurcerating or detaining Plaintiffs or any member of the class at the City While of St. Louis.

IT IS FURTHER ORDERED that this Order be stayed for a carifor of 30 days to afford an opportunity to bring the



City Jail of St. Leuis into full compliance with the requirements of the Constitution of the United States.

During the puriod of the 30-day stay, for the interim protection of the inmates of the City Jail of St.

Louis, and effective invadiately upon entry of this Order:

- (1) There thelk be at all times two guards on each floor of the City Jail of St. Louis where principles are confined and those guards shall coatinuously patrol within the areas where the prisoners are housed;
- (2) A program shall be instituted forthwith so that before the expiration of the 30-day period the population of the City Jail of St. Louis shall be reduced to not more than one man per cell and not more than four men per squad room;
- (3) No inmate in the City Jail of St. Louis shall have or be given any authority over any other inmate;
- (4) During the 30 days of the stay of this order, the Commissioner of Adult Services shall file with the Court daily reports as to the population of the City Jail of St. Louis and of every unusual incident occurring within the City Jail of St. Louis; such reports are to be available to counsel for the Plaintiffs and to the Amicus;
- (5) The Sheriff of the City of St. Louis shall keep one Deputy Sheriff and one vehicle on duty at the City Jail from 3 p.m. to 7 a.m. for the purpose of transporting inmates to an apporpriate medical facility maintained by the City of St. Louis and a vehicle and a Deputy Sheriff shall be available for that purpose from 7 a.m. to 3 p.m.

The Court reserves jurisdiction to make additional orders as required.
