ORDER

The Court grants the request of the City of St. Louis, presented by letter dated April 11, 1994, to increase the maximum population of the Medium Security Institution (MSI) to 550 detainees on April 25, 1994, provided the following personnel requirements are in place:

1. Ten of the additional staff members must have been on duty on or before April 22, 1994.
2. The two additional Correctional Counselors must be appointed and on active duty on or before May 15, 1994.
3. If for any reason full staffing of all 12 newly added staff are not on active duty by May 15, 1994, the City of St. Louis is directed to make up the reduced staff by authorizing overtime for the appropriate staff members until the staff is fully in place. In no case, however, is there to be any shortage of regular staff beyond

May 30, 1994, unless the City receives written permission to do so by this Court.

Failure to have adequate additional staff by May 30, 1994, may cause the Court to revert to a lower maximum ceiling for detainees at MSI.

SO ORDERED.
