ORDER

This matter is before the Court on the joint motion of the plaintiffs and the defendant the City of St. Louis to define "technical probation violator" and to establish a population ceiling for this category of 20 prisoners. Upon review of the material submitted by the parties, the Court concludes that the motion should be granted.

Accordingly,


IT IS HEREBY ORDERED that the joint motion of the plaintiffs and the defendant the City of St. Louis to define "technical probation violator" and to establish a population ceiling is granted.

IT IS FURTHER ORDERED that the term "technical probation violator" is defined as follows:

Any alleged probation violator, including an absconder, who is arrested and detained for an alleged probation violation, but does not have any other criminal charge

then pending against him or her. For purposes of this definition, an absconder is defined as a person who allegedly violated the terms of his or her probation by failing to appear or report as required.

IT IS FURTHER ORDERED that the number of technical probation violators detained in St. Louis City's detention facilities shall not exceed 20 prisoners at any given time.
