**ORDER SCHEDULING THE TRANSPORT AND TRANSFER  
OF CURRENT AND FUTURE OKLAHOMA COUNTY DETENTION CENTER  
INMATES SENTENCED TO THE CUSTODY OF THE DEPARTMENT OF  
CORRECTIONS**

On September 29, 2006, this Court ordered that all inmates in the Oklahoma County Detention Center who had been sentenced to state prison and were awaiting transfer to the custody of the Oklahoma Department of Corrections on that date were to be transported by the Oklahoma County Sheriff to the Lexington Assessment and Reception Center within 30 days, or on or before October 29, 2006. The Court further ordered that all future Oklahoma County Detention Center inmates sentenced to state imprisonment were to be transferred to the custody of the Department of Corrections within 45 days after the sheriff received the inmates' judgments and sentences.

This Court's order was stayed on October 19, 2006, by the Oklahoma Court of Criminal Appeals to permit it to consider a "Petition for Writ of Prohibition" filed by the Respondents herein, which sought to prevent the transfer of prisoners pursuant to this

Court's order. On February 1, 2007, the Court of Criminal Appeals issued its "Order Denying Application For Writ of Prohibition and Lifting Stay." In its Order, the Court of Criminal Appeals upheld this Court's authority to order such transfers, and it did not find that the time table established by this Court for the orderly transfer of inmates to the Department of Corrections to be unreasonable.

**IT IS THEREFORE THE ORDER OF THIS COURT** that the Oklahoma County Sheriff shall immediately notify and provide the Department of Corrections with the Judgment and Sentences for all sentenced inmates currently awaiting transfer to the Department of Corrections, and within 30 days of the date of this order, <sup>per the attached list</sup> the Sheriff shall transport any such inmates who have no further proceedings pending in Oklahoma County to the Lexington Assessment and Reception Center in Lexington, Oklahoma, where their custody is to be transferred to and accepted by the Department of Corrections at that facility. The Sheriff shall report to this Court upon the completion of these transfers.

**IT IS FURTHER ORDERED** that all future Oklahoma County Detention Center inmates who are sentenced to imprisonment in the state prison system, and who have no pending proceedings in Oklahoma County, shall be transported by the Oklahoma County Sheriff to the Lexington Assessment and Reception Center no later than 45 days after the Sheriff receives the Judgment and Sentence, where their custody is to be transferred to and accepted by the Department of Corrections.
