This matter is before the court on plaintiff's motion seeking entry of judgment for dismissal of plaintiff's ADA claims under Case No. 2:95-CV-0956. The court notes the following facts relevant to plaintiff's motion:

- (1) On January 16, 1998, this court signed an order consolidating Case No. 2:95-CV-0956 with Case No. 2:94-CV-754. At that time, Case No. 2:95-CV-0956 was closed. (Case No. 2:95-CV-956, dkt #75.)
- (2) On February 16, 1999, the court granted defendants' motion for summary judgment dismissing plaintiff's ADA claims. (Case No. 2:94-CV-754, dkt # 345.) A written order to that effect was signed on January 22, 1999. (Case No. 2:94-CV-754, dkt # 353.)
- (3) A jury verdict was entered on plaintiff's remaining claims on February 2, 1999. (Case No. 2:94-CV-754, dkt #350.)

Given these procedural facts, the court finds that it is unnecessary to enter the judgment requested by plaintiff. Case No. 2:95-CV-956 was closed at the time plaintiff's claims were consolidated under a single case number. An entry of final judgment in Case No. 2:94-CV-754, reflecting both the summary judgment orders and the jury verdict, will be entered shortly. There is no reason to enter a final judgment on the ADA claims under a case number terminated over a year ago. Accordingly, plaintiff's motion is DENIED.
