IT ORDERED, that the Clerk of the Court will deduct a registry fee authorized by the Judicial Conference Schedule of Fees implemented by the Administrative Office of the United States Court effective February 3, 1992 for the handling and servicing of interest bearing accounts deposited to financial institutions pursuant to 28 U.S.C. 2041 and Rule 67 of the Federal Rules of Civil Procedure. The amount of the fee shall be equal to ten percent (10%) of all income earned during the first five years, seven and half percent (7.5%) of all income earned during years six through ten, five percent (5%) of all income earned during years eleven through fifteen, and two and half percent (2.5%) of all income earned after fifteen years while funds are held in the Court's registry.

The Court ORDERS that the clerk make the check payable to said minor.

The Court ORDERS that the check be mailed to Dana Brockway. Her address is on file with the Court.
