1 On March 31, 2010, the court granted plaintiffs' motion
2 for summary judgment of liability on their claim that defendants,
3 in their official capacities, violated the Foreign Intelligence
4 Surveillance Act ("FISA"), 50 USC §§ 1801 et seq, but dismissed
5 plaintiffs' claims against FBI Director Mueller in his personal
6 capacity. Doc #721/115. On December 21, 2010, the court granted
7 the motion of plaintiffs Wendell Belew and Asim Ghafoor for
8 liquidated damages against defendants in their official capacities,
9 denied liquidated damages or any other recovery to plaintiff Al
10 Haramain Islamic Foundation, Inc, granted the motion of plaintiffs
11 Belew and Ghafoor for attorney fees and expenses, denied all other
12 relief requested by plaintiffs, granted plaintiffs' request to
13 dismiss without prejudice plaintiffs' Second, Third, Fourth, Fifth,
14 and Sixth claims for relief and directed the clerk to enter
15 judgment.

16 Now, therefore, IT IS HEREBY ORDERED, ADJUDGED AND
17 DECREED AS FOLLOWS:

- 18 1. Plaintiffs Ghafoor and Belew shall each recover a
19 total sum of \$20,400 in liquidated damages from
20 defendants in their official capacities Barack H
21 Obama, President of the United States; Keith B
22 Alexander, the Director of the National Security
23 Agency; Adam J Szubin, the Director of the Office of
24 Foreign Assets Control; and Robert S Mueller III,
25 the Director of the Federal Bureau of Investigation;
26 and
- 27 2. Plaintiffs Ghafoor and Belew and their counsel shall
28 recover a total sum of \$2,515,387.09 in attorney
