**PLAINTIFF PAUL'S MOTION TO LIST
NON-RESIDENTIAL ADDRESS IN COMPLAINT CAPTION**

Pursuant to instructions from the Office of the Clerk for the United States District Court for the District of Columbia, Plaintiff Rand Paul respectfully requests that he be permitted to use a P.O. Box address on the Complaint, in lieu of the residential address set forth in D.D.C.

L.Cv.R. 11.1. Plaintiff Paul is a United States Senator representing the Commonwealth of Kentucky. As a public figure, disseminating Plaintiff Paul's residential address via a publicly-filed complaint would needlessly impinge upon his personal privacy. Rule 11.1's purpose is to "facilitate service of process and effective communication between the parties." *Yaman v. United States Dep't of State*, 786 F.Supp.2d 148, 153 (D.D.C. 2011). Plaintiff Paul's mailbox, which is regularly checked, as well as his representation by undersigned counsel, ensure that he will receive any communications from the Court and other litigants.

Accordingly, Plaintiff Paul respectfully moves that he be permitted to file the Complaint using a P.O. Box in lieu of a residential address in the Complaint's caption.


