6 Specifically, these records are relevant to the authorized investigation in that they [give brief description of how the records sought are related to the investigation] 50 U S C 1861(a)(2)(B) ~~(S)~~

7 This application requests the Court to issue an unclassified ex parte order requiring the custodian of records to produce for the FBI the tangible things described in paragraph four above within five calendar days of service. 50 U S C §1861(c)(1). The United States also requests that the Court's order shall not disclose that it is issued for purposes of an authorized investigation conducted by the FBI under the FCIG. 50 U S C §1861(c)(2). This application also requests that the Court's ex parte order contain the following caveat: "No person shall disclose to any other person (other than those persons necessary to produce the tangible things specified in this order) that the FBI has sought or obtained the tangible things specified in this order." 50 U S C §1861(d). Further, this application requests that the ex parte order contain such other provisions as are set forth in the proposed order attached hereto. ~~(b)~~
