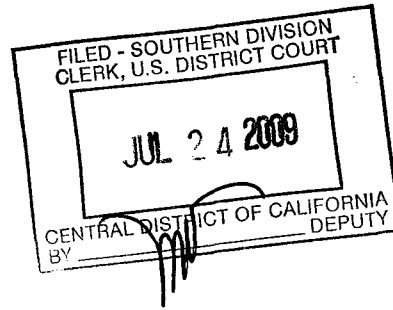



~~PROPOSED~~ ORDER OF
EXPUNGEMENT

1 Good cause having been shown, IT IS ORDERED THAT Defendants shall:
2 (1) seal, expunge or destroy permanently all records created on and after June 18,
3 2007 relating to arrests of or citations to Plaintiffs and other persons for violation
4 of the former provisions of Laguna Beach Municipal Code section 18.04.020 with
5 regard to camping or sleeping on public property; and (2) seal, expunge or destroy
6 permanently all records created on and after January 1, 2004 relating to arrests of
7 or citations to Plaintiffs, or any of them, for violation of the former provisions of
8 Laguna Beach Municipal Code section 18.04.020 with regard to camping or
9 sleeping on public property.

10 Defendants shall have thirty (30) days of the receipt of this order to
11 undertake and complete the sealing, expungement or destruction of the described
12 records and to furnish Plaintiffs' counsel with written notice of such completion.
13 Defendants also shall have thirty (30) days from the receipt of this order to request
14 in writing to their City Attorney and the Orange County District Attorney that any
15 copies of the described records in their possession either be sealed, expunged or
16 destroyed or be returned to the City. Such requests shall include a copy of the
17 Court's order. Defendants shall furnish Plaintiffs' counsel with a copy of such
18 requests and any written response to such requests.
