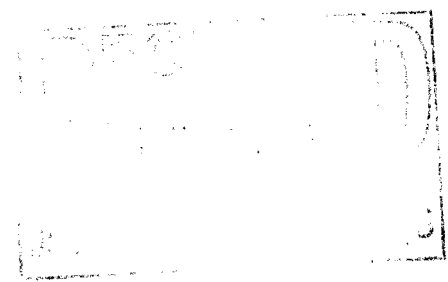

STIPULATION


