Dear Justice O'Connor:

I received today a copy of the letter written to Your Honor, dated March 23, 2017, from Kent T. Stauffer, Executive Deputy Attorney General. Our office represents the Plaintiff, John Doe, in this Article 78 proceeding.

While Mr. Stauffer did comply with Judge Garaufis' direction, it is Plaintiff's position that this proceeding is before Your Honor in state court, and it is not appropriate for Judge Garaufis, who is presiding over another action in federal court, to intercede in this action and purport to direct this Court what to do with its own Orders. It is further Plaintiff's position that this Article 78 proceeding is by no means moot when Mr. Doe returns to an adult home, and that the issuance of the injunctive relief was entirely appropriate and remains so.

If a motion is filed to vacate the TRO, Plaintiff intends to vigorously oppose it. The challenge to the regulations at issue is not just about Mr. Doe's right to return to an adult home, but also all the other discriminatory limitations on his rights imposed by these regulations.

Thus, it is not moot both as to Mr. Doe, or to the many others in similar positions who would bring similar actions due to the continuing discriminatory effect of the regulations upon them if the TRO were vacated.


