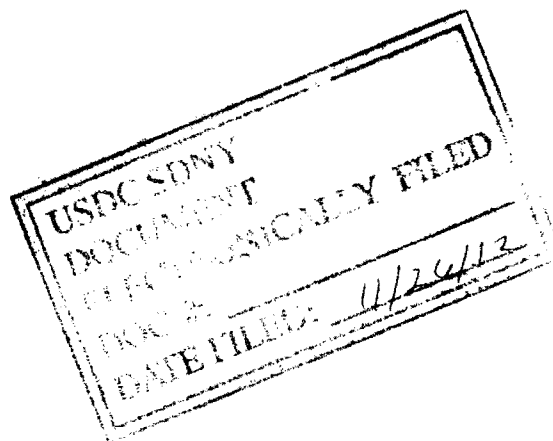




referred to in the City's letter will comply with a State directive to reinstate split-shift services to those individuals already being served by an MLTC provider.
