

18 The plaintiffs' motion for a preliminary injunction was
19 heard on the 31st day of August and the 1st day of September, 1977.

20 The Court heard all of the testimony offered by both
21 parties and, both parties having rested, the Court found that the
22 plaintiffs' constitutional rights under the eighth amendment to
23 the United States Constitution were being violated; and the
24 Court having made other findings heretofore announced in open
25 court this date, including, but not limited to, the fact that the
26 plaintiffs were likely to succeed in this action and that if pre-
27 liminary relief is not granted the plaintiffs will suffer irrepar-
28 able harm; and the Court having further found that good cause
29 exists for granting relief;

30 IT IS HEREBY ORDERED that the defendants, and each of
31 them, are prohibited and enjoined from allowing the male inmate
32 population at the Arizona State Prison at Florence to exceed 2,125

1 at any time hereafter until the 3rd day of October, 1977, at which
2 time the plaintiffs' motion for a preliminary injunction will be
3 further considered by the Court, and at which time the Court may
4 enter further and/or different orders.
