Pursuant to order of the Court, this matter came on for further review on the 21st day of November, 1978, and the Court, after having heard evidence and oral argument, makes the following orders:

IT IS ORDERED that the defendants will continue to reduce the population at the Arizona State Prison while providing needed programs at the prison as set forth in defendants' detailed plan admitted into evidence as Exhibit A.

2. IT IS FURTHER ORDERED that the defendants will provide the Court, counsel for the plaintiffs and the United States Attorney for the District of Arizona with the following:

(a) A written report on December 31, 1978 and February 28, 1979, describing the progress achieved by defendants in implementing the new classifications process for the Department of Corrections.

1 (b) A written report on December 31, 1978,
2 describing the policy of the Department of Corrections with
3 regard to the delivery of health care services for the inmate
4 population of the Department.

5 (c) Such other reports and/or information of a
6 form and substance as agreed upon by counsel for the parties and
7 the amicus curiae.

8 3. IT IS FURTHER ORDERED that this matter will come on
9 for review by the Court on the 17th day of April, 1979, at the
10 hour of 9:30 a.m., at the Federal Building, 230 North First Ave-
11 nue, Phoenix, Arizona.
