28 On March 26, 1997, the District Court established procedures by which Plaintiffs

1 are to collect periodic attorneys' fees and costs in this case in connection with their work
2 monitoring Defendants' compliance with the Court's Orders and collecting fees.

3 Pursuant to these procedures, on January 22, 2020, Plaintiffs served on Defendants
4 their Fourth Quarterly Statement for 2019 by overnight delivery. The parties completed
5 their meet-and-confer process on February 25, 2020 as to the fees and costs incurred on all
6 matters.

7 As a result of the February 25, 2020 agreement, the parties agree to the following:

8 The parties agree to the payment of \$1,912,871.74 to resolve all fees and costs
9 incurred during the Fourth Quarter of 2019, for monitoring and/or litigation activities in
10 the California Department of Corrections of Rehabilitation Division of Adult Operations
11 and Adult Programs (CDCR AOAP) portion of the case. Attached hereto as **Exhibit A** are
12 charts setting forth the fees and costs claimed by Plaintiffs and the amounts agreed to by
13 the parties to settle these claims.

14 The parties agree to the payment of \$110,118.99 to resolve all fees and costs
15 incurred during the Fourth Quarter of 2019, for monitoring and/or litigation activities in
16 the Board of Parole Hearings (BPH) portion of the case. Attached hereto as **Exhibit B** are
17 charts setting forth the fees and costs claimed by Plaintiffs and the amounts agreed to by
18 the parties to settle these claims.


19 The parties agree to the payment of \$177,756.15 to resolve all fees and costs
20 incurred during the Fourth Quarter of 2019, for monitoring and/or litigation activities in
21 the Division of Adult Parole Operations (DAPO) portion of the case. Attached hereto as
22 **Exhibit C** are charts setting forth the fees and costs claimed by Plaintiffs and the amounts
23 agreed to by the parties to settle these claims.

24 The parties agree to the payment of \$14,583.48 to resolve all fees and costs incurred
25 during the Fourth Quarter of 2019, for fees work. Attached hereto as **Exhibit D** are charts
26 setting forth the fees and costs claimed by Plaintiffs and the amounts agreed to by the
27 parties to settle these claims.

28 IT IS HEREBY ORDERED that the amounts set forth above are due and

1 collectable as of forty-five days from the date of entry of this Order. Interest on these fees
2 and costs will run from February 21, 2020, accruing at the rate provided by 28 U.S.C.
3 § 1961.
