Petition For a writ of Mandate in Re: Jordan vs Fitzharris  
# 44309 on habeas corpus.

To: The Honorable Judge, Presiding, In The above Entitled Court:  
Greetings:

Comes now, Robert Charles Jordan Jr., the petitioner, who respectfully  
motions and moves this Honorable Court for a writ of mandate, directed to  
and against the respondent, commanding him to cease and desist in  
obstructing the just and proper preparation of legal documentation and  
compilation of true and legal manuscripts.

Petitioner is engaged in a legal conflict and action with the respondent,  
and has various witnesses to, and of, certain acts and conditions and in order  
to properly litigate his action petitioner has drawn up affidavits of support,  
corroboration and confirmation to be signed by various persons under the  
custody of respondent.

These witnesses having prejudicial (to respondent) corroboration to  
affirm against respondent and tending to show respondent in his true criminal  
light, respondent has refused to allow said persons to sign said affidavits and  
has refused to allow any contact whatever between these persons and  
petitioner and has kept said rigidly segregated from petitioner.

These persons (witnesses) having informed petitioner of their willingness  
and desire to confirm and corroborate petitioner's complaint and allegations  
in the matter of Jordan v Fitzharris # 44309 and said testimony, and

affidavits (5) being of vital importance in the proper litigation of petitioner's cause and action, the actions of respondent in denying petitioner any and all means of obtaining these affidavits from willing signees is unjust and unlawful and an obstruction of justice.

Petitioner has pending a show cause order, on petition for a writ of Habeas Corpus and has until November 30<sup>th</sup>, 1965 to file a traverse and any other confirming and corroborating documents and evidence as may be available and does hereby say and state that the witnesses whose signatures he seeks upon affidavits are essential and vital to the just and proper litigation of his cause and action. Petitioner is appearing in this matter "in Propria Persona" and is entitled to any evidence that he may be able to present to this Honorable Court.

Therefore petitioner prays that this Honorable Court will issue the writ of Mandate against the respondent, directing him to cease and desist in his denial and obstruction and render petitioner all possible assistance in securing the signatures of his witnesses upon his prepared affidavits, said witnesses being voluntary and willing. Petitioner has been informed by officials under, and acting for, respondent that a court order will be necessary before they will allow petitioner access to these witnesses and before these persons would be allowed to sign any document whatever. Petitioner wherefore prays for the herein sought order in order to assure that Law, Order, and Justice will be served.
