Mr. Sir:

I would like very much to talk to someone from your office about a very
important matter.

I have a petition pending, in the United States District Court, San Francisco
County, against the officials of the Soledad Prison here, and a show cause order
has been issued against these officials by that court based upon that petition. Even
if the order has been issued these people (officials) here have been treating
in an abusive manner and casting threats attempting to intimidate me. They
delayed and stalled in processing my legal documents.

On the day of November 12, 1965, two petitions I gave to the Correctional Counselors
Decarte on Wednesday Nov. 10, 1965. I was told that I could not have
notarized as I had requested and that he, Decarte was not going to post
in the United States Mails and walked off and would not return.

One of these petitions was in direct connection with the show cause order
the Counselors had been informed on Nov. 5, 1965 (Friday) that it was
that the writ be mailed immediately and that they would be ready for
submission Monday morning, Nov. 8, 1965.

Despite repeated calls Monday, Tuesday, and Wednesday, (and the order
head Correctional Counselors, Mr. Keipura, on Monday to come and pick
up) Mr. Decarte refused to pick up the petitions until late Wednesday
noon, Nov. 10, 1965.

Mr. Decarte being the only official to handle legal papers here the fact that
I used, and continues to refuse, to mail my legal documents stops me from
out of access to the courts whatever with my petitions.

The Counselors here do not have the authority to refuse to pick up and mail
petitions to any court and this action by Decarte is just plain out and

considered discriminatory and illegal

He is attempting to prevent me from supporting ~~and~~ ⁱⁿ my action in the U.S. Courts and is just a continuance of other actions he taken prior to this, where he has before exceeded his authority in giving me actions and document in support of my legal action.

If it is at all possible, I would appreciate it very much if you will conduct an investigation into this matter.
