(t) Source shown is in error. The quotations are from the Program Operation Outline for "X" and "O" Wings dated May 1, 1965, page 10, 4h, and page 7, g1; not from Post Orders.

(ff) This is an error. Post Orders did not contain this statement. This was an unwritten policy.

(hh) The source quoted is in error. The quotations are from Program Operation Outline for "X" and "O" Wings dated May 1, 1965, pages 4 and 5, sections C and D; not from Post Orders.

(jj) The source quoted is in error. The authority is contained in Program Operation Outline for "X" and "O" Wings dated May 1, 1965, pages 4, 5, and 6, sections C, D, and E.


Interrogatory 26

Authority of each individual is as granted by the appointment of the individual by the Director of Corrections.

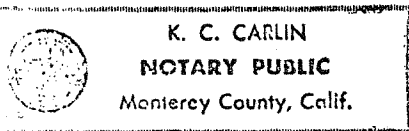
