1 On October 17, 2016, the parties advised the Court that they had
2 reached a tentative settlement of the action. [Dkt. #166.] The Court issued an
3 Order on October 19, 2016, requiring the parties to file a joint status report within
4 sixty days if the documentation regarding the settlement had not been finalized.
5 [Dkt. #167.] On December 19, 2016, the parties filed a joint status report noting
6 that settlement discussions were ongoing. [Dkt. #169.]

7 The parties have now reached a settlement and are working to finalize
8 the documentation. The parties expect to file such documentation with the Court
9 within 30 days.
