PLAINTIFFS' STATUS REPORT

Plaintiffs submit this status report pursuant to this Court's order of May 16, 1995 detailing the status of the 30 provisions. Pursuant to that order, the parties met on June 5, 1995, June 7, 1995, and with Grace Lopes on June 9, 1995, to discuss the 30 specific provisions that were stayed for 30 days by order of the Court.

The parties have reached an agreement in principle with respect to 21 provisions. Defendants are awaiting final approval from those officials with authority to authorize the modification of these 21 provisions. There are 2 paragraphs, ¶¶ 20 and 43, on which the parties have tentatively agreed on language, but which the Defendants still intend to seek a stay. The parties have likely reached agreement with respect to another 5 paragraphs, but require ten additional days to resolve the details of these provisions. Finally, there are 2 paragraphs, paragraphs 79 and 96, on which the parties are

unable to reach agreement. Plaintiffs will file a status report detailing their position on these two paragraphs, and any of the other provisions that cannot be resolved, at the end of the ten-day period.
