
ORDER OF PARTIAL DISMISSAL WITH PREJUDICE

Pursuant to the Stipulation of the parties (Doc. 235), the claims of Plaintiffs Kelvin Frazier, Antonio Ward, Charles Morgan, Sylvester Butler, Paul Echols and Reginald Williams for money damages against Defendants James V. Crosby, Jr., Bradley Carter, George Sapp, Stephen Sirmones, Joe Lazenby, Jr., Allen Clark, Mark Redd, Keith Musselman, Tony Anderson,

James Wilson, William Muse, Colin Halle, Steven Tricocci, Tim Chastain, Rodney Barnett, Ronnie Barton, Kenneth Lampp, Wendell Whitehurst, Stacey Green, David Reynolds, John Riggs, Glynn Reeder, John Rizer, Oscar Shipley, Dean Ellis, Jeffrey Lindsey, and Bill Jarvis are dismissed with prejudice, each party to bear the responsibility for their respective costs and attorneys' fees, if any.

Nothing in this Order of Partial Dismissal with Prejudice affects the claims of Plaintiffs Kelvin Frazier, Antonio Ward, Charles Morgan, Sylvester Butler, Paul Echols and Reginald Williams for declaratory and injunctive relief, and costs and fees, against Defendants James McDonough and Randall Bryant, and nothing in this Order of Partial Dismissal with Prejudice affects any of the relief sought by Plaintiffs Jeremiah Thomas, Eugene Ulrath, Curt Massie, and Michael McKinney, against any of the Defendants
