I, Brian Nelson, affirm and attest that the following is true and correct under penalty of perjury:

2. I am an adult over the age of 21 years old. I am employed as the Prison Rights Coordinator at the Uptown Peoples Law Center.
3. Among my responsibilities is reviewing all prisoner correspondence received by UPLC. I categorize the issue addressed in the request for assistance enter the information into a data base and either prepare a form response, request additional information, or forward the letter to one of the attorneys if it relates to a pending case.
4. Due to the large amount of mail received in *Rasho et al., v Baldwin et al.*, I worked with the other counsel representing plaintiffs in *Rasho* to create and populate a

shared chart to track the requests made by class members, and our responses.

The chart is shared by all co-counsel, both to allow tracking of communications, and to ensure that duplicate information is not provided to prisoners who may write more than one counsel. The information collected includes:

- A. Last name
 - B. First Name
 - C. IDOC Number
 - D. Date of class member's letter requesting information
 - E. Counsel responding
 - F. Date information is sent to class member
 - G. Objection Date
 - H. Class member's prison facility
5. Uptown People's Law Center received a request for information from Mr. Trinidad Botello (K76540) on January, 14 2016.
 6. On January 21, 2016, I copied the requested documents and placed them in the outgoing mail addressed to Trinidad Botello K76540 at Menard Correctional Center P. O. Box 1000 Menard, Illinois 62259.
 7. On March 4, 2016, at the request of Alan Mills, I sent another set of the requested documents to Trinidad Botello at the same address. This second mailing included:

B. Settlement Agreement, filed January 21, 2016,


C. Second Amended Class Action Complaint, filed April 29, 2011, and
